 to our schools to share different perspectives, faiths and cultures

- How we will achieve it: we plan to analyse registers of attendance and parent/pupil questionnaires. A full review of the after-school club offer will be conducted and children's voice sought about what they would like to access.
- **Objective 3:** To ensure our school environment are accessible as possible to all pupils, staff and visitors.



- How we will achieve it: we plan to update our accessibility plans and review them regularly
- **Objective 4:** To eradicate prejudice-related bullying in relation to the protected characteristics listed in the Equality Act 2010.
- How we will achieve it: we plan to create effective systems for recording
 incidences of discriminatory behaviours. Ensure systems allow swift identification of
 any issues, prompt and effective action involving parents where necessary and
 comprehensive recording.
- **Objective 5:** Actively close gaps in attainment and achievement between pupils and all groups of pupils; especially students eligible for free-school meals, students with special educational needs and disabilities and looked after children
- How we will achieve it: we plan to modify the provision in order to meet all
 children's needs and interests. Introduce more specific interventions for English and
 Numeracy that are bespoke to the children's needs and generated as a result of
 thorough diagnostic assessments. Improve parental engagement by coming into our
 schools and being part of the learning experience.
